

Emissions Recall 67A



The Heavy-Duty Ram Emissions Recall 67A Special Extended Warranty covers the cost of all parts and labor needed to repair the listed items for all U.S. owners and lessees of Model Years 2013-2018 RAM 2500 and RAM 3500 pickup trucks powered by Cummins 6.7L Turbo Diesel engines who receive the software update.

Once customers complete the software update, they automatically receive **free Special Extended Warranty coverage.**

Eligibility is contingent on Stellantis/FCA's standard terms and conditions, which include eligibility exclusions for accident, abuse, neglect, and tampering. All applicable existing warranty provisions remain in effect.

*The Special Extended Warranty will cover the cost of any On-Board Diagnostic (OBD) scan for malfunctions that trigger the OBD malfunction indicator light (MIL), regardless of whether the malfunction is related to a part covered under the Special Extended Warranty.

**Although Cummins does not expect any damage to the hardware of the Selective Catalyst Reduction (SCR) Controller due to the software update, if any occurs, Cummins will replace the hardware at no cost to the customer and provide a 2-year parts warranty for the replaced part.

Warranty Extension Coverage Period

Coverage period is the **greater of:**

- 10 years from the date of initial sale or 120,000 miles on the odometer (whichever comes first)
- OR**, 4 years or 48,000 miles from the date of Emissions Recall 67A completion (whichever comes first)

Coverage period cannot exceed December 31, 2033, for any eligible vehicle that receives Emissions Recall 67A after April 9, 2027.

Already replaced a component without receiving the Special Extended Warranty?

The Special Extended Warranty coverage begins when an affected U.S. owner/lessees receives the software update. **Affected U.S. owners/lessees will be reimbursed for eligible repairs if they have paid for a covered repair or service.**
